



## **Notice of Fiscal Year 2027 and Fiscal Year 2028 CHSP Funding Opportunity and Mandatory Workshops**

The City of Tallahassee and Leon County invite all interested non-profit human service organizations to participate in the Fiscal Year 2027 and Fiscal Year 2028 funding cycle of the Community Human Service Partnership (CHSP) grant process. To apply for funding, the organization must provide direct human services to residents of the Tallahassee/Leon County area.

Each year, Leon County and the City of Tallahassee provide funding to non-profit human services organizations to provide safety net services to vulnerable citizens.

The primary mechanism for supporting human services is through the Community Human Service Partnership, which provides investment in a broad range of human service programs implemented by local nonprofits. The City and County fund human services programs with general funds, supplemented by federal and state grants such as the Community Development Block Grant from the U.S. Department of Housing and Urban Development and Change for Change, a City utility customer donation program.

**All agencies that intend to apply for the Fiscal Year 2027 and Fiscal Year 2028 funding cycle must attend ONE of the mandatory application workshops and ONE of the mandatory budget workshops offered.**

The **deadline to register** for mandatory workshops via **CHSPPortal.org** is **Friday, Jan. 30, 2026**.

All workshops will be held at the Leon County Office of Human Services and Community Partnerships, 615 Paul Russell Road, Tallahassee, FL 32301.

  - Wednesday, Feb. 4, 10 a.m. – 12 p.m.
- Agencies applying on Team 12 – Gun Violence Intervention\*
  - Wednesday, Feb. 4, 2-4 p.m.

*\*Agencies applying on both teams 11 and 12 should attend both workshops.*

### **Mandatory Budget Workshop Schedule**

- Thursday, Feb. 19, 2-4 p.m., or Wednesday, Feb. 25, 10 a.m. – 12 p.m.

**Applications will only be accepted from agencies that meet the CHSP eligibility criteria at the time of application and have documented attendance at one of the mandatory application workshops and one of the mandatory budget workshops.** CHSP grant eligibility criteria is listed at **CHSPPortal.org**.
